*Mr. Johnson,*

*I am still trying to make contact with individuals in the Office of the General Counsel and the Office of the Secretary. When I have made the right contacts I will provide you with contact information. I believe in preparing the way for Mr. Schafer. A decision to terminate the Hutterite's farm subsidies will affect about 10,000 people and will have serious consequences for the Hutterites for generations to come. I believe the Hutterites will try to legally challenge a USDA decision to terminate their farm subsidies. As a result, the case could attract media attention and could become a high-profile case. For all of the reasons mentioned, I believe it is necessary for Mr. Schafer to make a decision about my complaint.*

*I believe a legal foundation has been established to make the case to terminate the Hutterite's farm subsidies. I sent a letter of introduction to several Hutterite colonies in the Lewistown, Montana area in November 2007. I received a letter from Mr. Hofer of King colony in March 2008. The letter is signed and dated so I believe it is admissible as evidence in a court of law. In the letter Mr. Hofer establishes a closed admission policy for all Hutterite colonies. When you read the letter I believe you will realize why it is necessary for me to file a complaint with USDA.*

*Mr. Johnson,*

*I need to inform you that I have been able to find the IRS tax filing information for King colony in Lewistown, Montana. King colony has filed with the IRS as a 501 (d) religious and apostolic association. This information establishes King colony as a nonprofit religious organization. To find the tax filing information for King colony at the website [www.melissadata.com] make the following steps:*

- 1) On the homepage, click on the topic 'Lookups'.*
- 2) On the 'Lookups' webpage, find the topic 'Federal Resources', and click on 'Nonprofit Organizations'.*
- 3) In the information box that appears, enter the name Peter Hofer.. Then click on the Submit character.*
- 4) A data box will appear with a link to Peter Hofer Etal Ptr. Click on the link.*

*You may be interested to know that King colony has been involved in a court case concerning eligibility for Medicaid benefits. The court case is referred to as Hofer v. Montana Dep't of Public Health and Human Services, December 6, 2005. A trial judge ruled in favor of the Hutterites, but the Montana Supreme Court ruled in favor of the state Medicaid agency to deny Medicaid benefits to the Hutterites. *This court case demonstrates the fact that the Hutterites at King colony are willing to set up a erroneous interpretation of their business position, in order to make a claim for Medicaid benefits. The colony claimed that their financial assets are shielded from their members being able to access the financial assets. The Montana State Department of Public Health and Human Services argued that King colony established a "trust relationship" through its founding documents, so colony members have access to the colony's financial assets.*

*Mr. Johnson,*

*I have found some more information relevant to my Hutterite complaint that I believe will be helpful to you in your investigation of my Hutterite complaint, and in making a determination about the Hutterite's eligibility for USDA farm subsidies.. I searched the website [www.melissadata.com] for tax filing information about Hutterite colonies by searching for the name Hutterian Brethren. I found a list of 85 nonprofit organizations that include the name Hutterian Brethren and are filing with the IRS as a nonprofit organization.*

*There are 55 names on the list that resemble or match names listed in the EWG Farm Subsidy Database at the website [www.ewg.org], and the names are in the same geographic location as the names listed in the EWG Farm Subsidy Database. The practice of a Hutterite colony when the colony reaches a certain population is to form a branch colony, so the 55 names are 55 Hutterite colonies that are receiving USDA farm subsidies.*

*The list is substantiating evidence for a profile of a Hutterite colony as a nonprofit religious organization, with a closed admission policy, that has incorporated as a business but cannot offer full-time permanent employment to the public because of their tax exempt status.*

*To find the list at the website [www.melissadata.com] make the following steps:*

- 1) On the homepage, click on the topic 'Lookups'.*
- 2) On the 'Lookups' webpage, find the topic 'Federal Resources', and click on 'Nonprofit Organizations'.*
- 3) In the information box that appears, enter the name hutterian brethren, then click on the Submit character.*

*I will mail to you a copy of the list, and a copy of the tax filing information, a copy of a business profile, and a copy of the EWG USDA farm subsidy information for 3 Hutterite colonies on the list that I can exactly match the name on the list with the name in the EWG Farm Subsidy Database, as substantiating evidence for my Hutterite complaint.*

*With the addition of this information to my Hutterite complaint, I believe I can establish conclusive evidence to terminate the Hutterite's USDA farm subsidies. As a result of my Hutterite complaint, I believe it may be necessary to revise the USDA farm subsidy program eligibility requirements. To accomplish this step, it may be necessary to revise the Farm Act in the Commodity Programs section of the Farm Bill.*

*I have come to realize that a farm subsidy program revision can terminate the Hutterite's farm subsidies but the revision may not apply retroactively to the Hutterite colonies that are currently receiving USDA farm subsidies. So, to achieve termination of the USDA farm subsidies currently given to the Hutterite colonies, I believe I will need to establish the evidence for each Hutterite colony that is necessary to terminate the colony's USDA farm subsidies.*

*I am requesting information concerning the steps necessary to revise the USDA farm subsidy program eligibility requirements and the steps necessary to accomplish a retroactive termination of the USDA farm subsidies currently given to the Hutterite colonies.*

*I am bringing the new information relevant to my Hutterite complaint to the attention of Mr. Keppy and*

*Mr. Jackson.*

Mr. Johnson,

*I have received your letter as a statement concerning the resolution of my Hutterite complaint. I have confirmed by my US Postal Service certified mail receipts that you received the new evidence I mailed to you. The new evidence establishes the fact that King colony is filing with the IRS as a 501(d) religious and apostolic association and has been tax-exempt since 10-1948. The new evidence establishes a profile of a Hutterite colony as a nonprofit religious organization. I believe I made it clear that as a result of the new evidence a determination to terminate the Hutterite's USDA farm subsidies did not have to be made based on a closed admission policy. I believe a determination can be made based on the fact that a Hutterite colony is a nonprofit religious organization with a tax-exempt status that cannot offer the same full-time permanent employment position to the public as a business can offer to the public. The public will not be able to receive a return of equal value to their investment in a Hutterite colony in the form of USDA farm subsidies. So, there is no reason for the public to support USDA farm subsidies for a Hutterite colony. I believe the scale is out of balance and it will be necessary to fix the problem.*

*It appears that you have chosen to ignore the new evidence and consider it irrelevant. I believe the new evidence is relevant to making a determination to terminate the Hutterite's USDA farm subsidies and should be considered in the resolution of my Hutterite complaint. I believe my case should remain open so the resolution of my Hutterite complaint can be made based on all of the evidence I have submitted to USDA.*

*For your information, I will be filing a objection concerning your closure of my case with Mr. Keppy and Mr. Jackson. I hope my objection will be accepted, or in legal terminology 'sustained'.*

*For your information, I will be filing my updated Hutterite complaint with the House Committee on Agriculture after the November Presidential election. It will be necessary for me to file my updated Hutterite complaint with Chuck Conner and Ed Schafer so they will have the same information as the House Committee on Agriculture.*

Dear Mr. Eichorn:

This is in further response to your complaint about Hutterite colonies receiving payments under USDA programs. It is your contention that what you term "new evidence" should be a basis for denying payment to a Hutterite colony. You also object to this matter being considered closed.

Again, an "open admissions policy" is not an eligibility requirement for participation in USDA programs. A nonprofit religious organization can, in fact, be eligible for the payments you seek to deny. There is no applicable statutory or regulatory requirement for an entity to offer employment positions to the public. Likewise, your characterization of USDA payments to an eligible program participant as an "investment" requiring the public to receive a return of equal value has no support in statute or regulation.

We fully understand that you have your opinions and believe there is a "problem" that needs to be fixed. You are entitled to your opinions. However, there is neither a statutory nor a regulatory basis for denying the payments for the reasons you suggest. As indicated in our prior response, we consider this matter closed. We will provide no further response.

*Mr. Keppy,*

*I spoke to Cherri Carpenter, Executive Assistant to the Secretary, Secretary of Agriculture Office, on Tuesday July 8. She informed me that a staff person would not be able to make a special arrangement to receive my complaint, since their is a correct procedure for the office to receive mail. I will mail my complaint to the Secretary of Agriculture Office and I will send a e-mail to Chuck Conner, Deputy Secretary of Agriculture, and Ed Schafer, Secretary of Agriculture, to inform them that my complaint will be available for them to review.*

*Since I will not be able to establish a contact person for my complaint in the Secretary of Agriculture Office at this time, I need to ask you if you are willing to act as a USDA/FSA contact person to handle inquiries concerning my complaint. The reason why I ask is because I will be sending my complaint to a number of people in positions of authority including Montana Representative Dennis Rehberg, South Dakota Representative Stephanie Sandlin, and the House Committee on Agriculture.*

*Since my complaint is a public service to the US taxpayer, I want to make sure that the public interest is fairly represented in a USDA decision concerning the Hutterite's USDA farm subsidies. I will be filing my complaint with public interest groups like Public Citizen, Environmental Working Group (EWG), and Citizens Against Government Waste (CAGW). I believe these groups are in a better position than I am to keep track of the agriculture policy changes and farm subsidy program eligibility requirements changes that may be made by the US Government or USDA.*

*I believe these individuals and groups may want to contact USDA for information about a USDA solution to the Hutterite problem.*

*For my own information, I would like to know who would be in a position to make a change to the USDA farm subsidy program eligibility requirements. I believe the House Committee on Agriculture is responsible for agriculture policy and the Farm Bill, so the committee is in a position to make policy changes. I am wondering if USDA is able to make technical changes to the Farm Bill that would allow USDA to make eligibility requirements changes.*

*I sent my complaint to Mr. Johnson and Mr. Jackson so they should have received it by now. If you have any questions about Mr. Johnson's investigation of my complaint he should be able to answer them for you. If you have any legal questions or need legal advice Mr. Jackson should be able to advise you.*

However, subject to that, I want to tell you that I am not aware of any authority to deny payments based on a closed admission policy.

Closed corporations for example receive payments, partnerships do as well.

*I want to inform you about a few developments concerning my 'Hutterite USDA farm subsidy complaint' at USDA.*



One month passed with no response from Mr. Taitano, so I decided to send a letter of inquiry to Phyllis Fong, USDA Inspector General. I can confirm that her office received my letter on 7/13/09. A OIG investigation should be under way.*

I want to inform you about a few developments concerning my 'Hutterite USDA farm subsidy complaint' at USDA.



My complaint requires attention at the national level because it is national in scope. The Hutterite colonies are located in Minnesota, Montana, North Dakota, South Dakota, and Washington. I have filed my complaint with the following individuals at USDA:*

- a) *Glen Keppy - FSA/Associate Administrator of Programs  
Mr. Keppy will be acting as a FSA coordinator for my complaint.*
- b) *John Johnson - FSA/Deputy Administrator of Farm Programs  
Mr. Johnson will be acting as a FSA investigator for my complaint.*

For all of the reasons mentioned, I believe it is necessary for you to make a decision about my complaint.*





### **Agency Leaders Prepare to Depart, Administrator Lasseter Bids Final Farewell**

The daily 8 a.m. meetings in the FSA administrator's office have been peaceful and a bit reflective for the past two weeks. Nevertheless, business has not stopped.

Progress reports on the implementation of the 2008 Farm Bill still lead most conversations, followed by updates on the MIDAS project and, of course, budget matters. Still, the aura is one of completion and the passing of the baton. But for now, the baton is being handed off to a team of career employees, very busy place keepers until a fresh group comes in carrying a new torch.

On Jan. 21, Deputy Administrator for Farm Loan Programs Carolyn Cooksie will become the acting administrator for FSA. She has implied that the shorter her "acting" career, the more tolerable is the stage. Already she has said that she is eager to have just the one title that she has borne for several years. However, that will be up to a new president and secretary of agriculture, one to take office next Tuesday and the other already in the sidelines awaiting his orders to begin.

For those leaving FSA – Administrator Teresa Lasseter; Associate Administrators Tom Hofeller and Glen Keppy; Deputy Administrators John Johnson, Steve Connelly and Larry Adams; Office of External Affairs Director Patricia Klintberg; and Assistants to the Administrator John "Moot" Truluck, Mike Wild and Adam Guzzo – this week completes their assignments to FSA, which extended through several years of dramatic change.

In the states, it means most executive directors will be leaving, but a few have been asked to stay in place to work with the new political leadership.

On Thursday, Administrator Lasseter sent all employees an email:

Today will be my last day in the office and I will be officially gone from FSA as of noon, Tuesday, January 20. I want to express to each of you my sincere thanks for all the support and cooperation you have given me as your FSA Administrator.

We have accomplished much the past three years, often with limited resources and tight timelines. Many times I felt I was asking the impossible but you always came through! The best example I can give you is the Improper Payment situation we found ourselves in and how we made vast improvements – by working together and working diligently!

I have many fond memories from my 31 years around the agency, but serving as your Administrator has been the most rewarding as I had the pleasure of getting

to know many of you, visiting your offices, learning more about agriculture in your states and helping solve various challenges you faced. As I have said to you many times before, you should feel good about yourselves because of the contribution you make to our great country, our farmers and ranchers. The mission of FSA is important to the well being of our country!

My USDA email will be disconnected after 10:00 am today and I want each of you to have my personal contact info. Please feel free to contact me at Teresa.....@ (omitted).

No one knows for certain how long the transition will take, but many at headquarters have recalled what occurred in 2001, when the agency operated for a year or longer without associate and deputy administrators. It took until November 2001 for all 50 states to have their state executive directors in place.
