Based on information I found on the Internet, I was led to believe that to be able to file a complaint with your committee I am supposed to file the complaint with the US Representative who represents the congressional district of my residence. So, I filed my complaint with Congresswoman Nancy Pelosi's San Francisco District Office on March 31, 2009, to be forwarded to her Washington, DC Office, for delivery to your committee.

It has been 3 months now and I have not received a letter of confirmation from Nancy Pelosi's Washington, DC Office. I decided to call Collin Peterson's Washington, DC Office to inquire about filing a complaint with your committee. The person I spoke to on the phone said I can mail a complaint directly to your committee. So, I have enclosed my complaint for the House Committee on Agriculture.

I have changed the complaint letter date from March 21, 2009, to July 21, 2009, to bring the complaint letter up to date. I have deleted a note at the end of the complaint letter concerning filing the complaint with Nancy Pelosi's office, and contact information for Nancy Pelosi's office. This information is irrelevant to the complaint, so this version of the complaint is the same basic version as the original complaint. I have made these changes because I want to use this version of my complaint for my record.

I realize your committee may have already received my complaint from Nancy Pelosi's Washington, DC Office and sent a statement concerning the resolution of my complaint to me. At this point in time, I have not received a statement from your committee. I am requesting a statement from your committee concerning the resolution of this version of my complaint, so both you and I know you have considered all of the complaint material. Nancy Pelosi's office has my original complaint in a unsealed envelope and it is available for review. I have provided contact information for sending a statement to me in the complaint letter, so please refer to this contact information.

I have provided contact information for Nancy Pelosi's Washington, DC Office if you want to contact her office.

HCA,

I am writing to file a complaint concerning the USDA farm subsidies given to over 100 Hutterite colonies in the USA. My complaint requires attention at the national level because it is national in scope. The Hutterite colonies are located in the states of Minnesota, Montana, North Dakota, South Dakota, and Washington. As of 2006, there are over 100 Hutterite colonies in the USA that are receiving USDA farm subsidies, so farm subsidy payments to the Hutterite colonies for generations to come will amount to trillions of dollars. The calculation can be confirmed by checking The Environmental Working Group's Farm Subsidy Database at the website [www.ewg.org] for the USDA farm subsidy information for the Hutterite colonies. I will be making the case to terminate the Hutterite's USDA farm subsidies. I believe I can establish a legal foundation, based on evidence, to make the case.

I am filing my complaint with your committee for the following reasons:

- a) To bear witness to the fact that USDA farm subsidies for Hutterite colonies are a violation of the public-interest by resulting in a financial loss for the public.
- b) To bear witness to the fact that current USA farm policy as expressed in the Farm Bill is allowing a violation of the public-interest to occur. As a result of my complaint, I believe it may be necessary to revise the Farm Bill to correct the problem and to accomplish a change to the USDA farm subsidy program eligibility requirements.
- c) To bring to your attention the progress of the resolution of my complaint at USDA in Washington, DC. According to statements I received from USDA in 2008, there is no statutory or regulatory basis for denying farm subsidies to Hutterite colonies for the reasons I established as a basis for terminating their farm subsidies.
- d) To establish allegations concerning Secretary of Agriculture Tom Vilsack allowing a violation of the public-interest to occur by closing my case at USDA and failing to act to terminate the Hutterite's USDA farm subsidies, and his misconduct in office.

To begin my case,

I sent a letter of introduction to Ayers colony, King colony, and Spring Creek colony, in November 2007. These Hutterite colonies are located in the Lewistown, Montana area. I believed in the Hutterite way of life, and I thought I could make a positive contribution to a Hutterite colony, so I expressed my interest in joining a Hutterite colony. I received a letter from Walter Hofer of King colony in March 2008 that establishes a closed admission policy for all Hutterite colonies. In the letter Mr. Hofer says,

"...it is impossible for you to join a Hutterite colony. I have brought your letter to the attention of our colony members and other members among different colonies. We are all in agreement that it is impossible for you, or anyone else, to join a Hutterite colony."

King colony is operating as a nonprofit religious organization affiliated with the Hutterian Brethren Church and has incorporated as a business in the USA. I believe

Mr. Hofer is acting as a representative of King colony and the Hutterian Brethren Church so the closed admission policy can apply to all Hutterite colonies.

I have enclosed a copy of Walter Hofer's letter.

I can establish Walter Hofer as a member of King colony by his ownership percentage share of 1.86% in King colony. This information is from the USDA farm subsidy information for King colony in The Environmental Working Group's Farm Subsidy Database at the website [www.ewg.org] (Update 2009 - link to [www.mulchblog.com]). I have enclosed a copy of a webpage with the information. (The USDA information lists King colony as King Ranch Colony. The different names represent the same Hutterite colony)

I can establish the Hutterite's link to the Hutterite United Brethren Church, established in 1950, by a timeline from the website [www.organicperspective.com]. The 3 branches of the Hutterites decided to form this church to establish a better position. I have enclosed a copy of a webpage with the timeline information. The original Hutterite church, known as the Hutterian Brethren Church, is known to have originated around 1525. I have enclosed a copy of webpages with contact information for the Hutterian Brethren Church in various forms. This information will establish the existence of the Hutterian Brethren Church in the following forms:

(information found at the website [www.ic.gc.ca])
- d) The Hutterian Brethren Church - Calgary, Alberta, Canada
(information found at the website [www.strategis.ic.gc.ca])

The Hutterite colonies I contacted are listed on a webpage at the website: [www.destinationlewistownmontana.com]. The webpage includes contact information for the colonies. I have enclosed a copy of the webpage.

From my research, I became aware of the fact that Ayers colony, King colony, and Spring Creek colony, are receiving USDA farm subsidies. From 1995-2006 these colonies received the following farm subsidies:

- a) Ayers colony: \$337,154
- b) King colony: \$668,415
- c) Spring Creek colony: \$908,706

The information is from The Environmental Working Group's Farm Subsidy Database at the website [www.ewg.org] (Update 2009 - link to [www.mulchblog.com]). I have enclosed a copy of the webpages with the USDA farm subsidy information. (Ayers colony is listed as Ayers Ranch Colony Inc, and King colony is listed as King Ranch Colony, in the USDA information. The different names represent the same Hutterite colony)

I have found the IRS tax filing information for Ayers colony and King colony. Ayers colony and King colony are filing with the IRS as a 501(d) religious and apostolic association and are tax-exempt. Ayers colony has been tax-exempt since 12-1967 and

King colony has been tax-exempt since 10-1948. I have not found the IRS tax filing information for Spring Creek colony.

I have enclosed a copy of the IRS tax filing information for Ayers colony and King colony from the website [www.melissadata.com]. I have enclosed a copy of a business profile for both colonies from the website [www.manta.com] for comparison with the IRS tax filing information.

I searched the website [www.melissadata.com] for tax filing information about Hutterite colonies by searching for the name Hutterian Brethren and I found a list of 85 nonprofit organizations that include the name Hutterian Brethren and are filing with the IRS as a nonprofit organization. The majority of names on the list resemble or match names listed in the EWG farm subsidy database and are located in the same geographic location as the names in the EWG farm subsidy database. The practice of a Hutterite colony when the colony reaches a certain population is to form a branch colony, so the names are Hutterite colonies that are receiving USDA farm subsidies as of 2006. As examples, I have enclosed a copy of webpages with the IRS tax filing information, a business profile, and the EWG USDA farm subsidy information, for 3 Hutterite colonies on the list that I can exactly match the name from the list with the name in the EWG farm subsidy database. I have enclosed a copy of a webpage with the list of 85 nonprofit organizations.

The business profile for the Hutterite colonies gives a estimate of the number of employees at the location. The employee estimate for the following colonies is:

- a) Ayers colony (Ayers Ranch Colony Inc): 40 employees
- b) King colony (King Ranch Colony, King Colony Ranch Inc): 15 employees
- c) Bon Homme colony (Bon Homme Hutterian Brethren Inc): 26 employees
- d) Clearfield colony (Clearfield Hutterian Brethren Inc): 3 employees
- e) Rockport colony (Rockport Hutterian Brethren Inc): 120 employees

I believe the employees are members of the Hutterite colony. I believe if you take a tour of any Hutterite colony you will not find public employees in a full-time permanent employment position. I believe you will not find public employees in any employment position at a Hutterite colony. A estimate of the population at a Hutterite colony is 50-100 people so a Hutterite colony does not have a shortage of labor.

I do not think you will find a public employment record for any Hutterite colony because of their tax-exempt status. If you find a employment record for a Hutterite colony I do not think you will find any public employees on the record. A FBI investigation can be made to determine the facts about the employment record of a Hutterite colony.

The IRS tax filing information for Ayers colony and King colony, the list of 85 nonprofit organizations, and the examples of the 3 Hutterite colonies, are substantiating evidence for a profile of a Hutterite colony as a nonprofit religious organization affiliated with the Hutterian Brethren Church, with a closed admission policy, that has incorporated as a business but cannot offer the same standard full-time permanent public employment position as a business can offer because of their tax-exempt status.

A nonprofit organization cannot offer to the public a full-time permanent employment position with the same employee compensation package as a business can offer to the public. I believe the nonprofit organization's public employee compensation package will not include unemployment compensation, a company health plan, a company retirement

plan, or Social Security benefits. I believe a nonprofit organization cannot offer to the public a full-time permanent employment position of equal value to the standard full-time permanent public employment position at a business. If the public cannot establish a full-time permanent employment position at a Hutterite colony that is of equal value to the standard full-time permanent employment position at a business, then the public will not be able to receive a return of equal value to their investment in a Hutterite colony in the form of USDA farm subsidies. I believe USDA farm subsidies for a Hutterite colony is a losing proposition and a bad investment for the public. I believe there is no reason for the public to support USDA farm subsidies for a Hutterite colony.

For the purpose of example, if I put a nonprofit organization's full-time permanent public employment position on a scale, and a business's standard full-time permanent public employment position on a scale, the result will be a unbalanced scale. The 2 sides will not be equal in value so the scale will be out of balance. I believe the scale is out of balance and the problem needs to be corrected.

I can establish documentation of the definition of a nonprofit organization from the US Code of Federal Regulations, Title 32, 37.1315. I have enclosed a copy of a webpage with the information from the Electronic Code of Federal Regulations, from the website [www.gpoaccess.gov], for your reference.

I can establish documentation of a overview of the current legal knowledge concerning non-profit organizations. I have enclosed a copy of a webpage with the information from the Cornell University Law School website [www.law.cornell.edu]. The information supports my belief concerning the inequality of the public employment offering of a nonprofit organization compared to the public employment offering of a business. The overview establishes the following points:

- a) Some states exempt non-profit organizations from state tax and state employment programs such as unemployment compensation contribution.
- b) Social security tax is currently optional.

Mr. Hofer's establishment of a closed admission policy for all Hutterite colonies confirms my belief that a Hutterite colony has no real intention of offering full-time permanent employment to the public. I believe a closed admission policy is a model of exclusion and is the opposite of a model of inclusion. I believe the Hutterite colonies that are receiving USDA farm subsidies are doing so with absolutely no consideration for offering the public anything in return. I believe these Hutterite colonies are making a fraudulent claim for USDA farm subsidies under the false pretense of operating as a business, when in fact they are operating as a nonprofit religious organization with a tax-exempt status.

I believe a determination to terminate the Hutterite's USDA farm subsidies can be made based on the following facts:

- a) A Hutterite colony is a nonprofit religious organization that cannot offer the same standard full-time permanent public employment position as a business can offer because of their tax-exempt status.
- b) If the public cannot establish the standard full-time permanent employment position at a Hutterite colony, then the public will not be able to receive a return of equal value to their investment in a Hutterite colony in the form of USDA farm subsidies.
- c) A simple equation can express the relationship of the Hutterite's USDA farm subsidies to the public's investment as follows:

Hutterite's USDA farm subsidies as financial gain = financial loss for the public

I have come to realize that a Hutterite colony should never have started to receive USDA farm subsidies. Giving farm subsidies to a Hutterite colony is like giving farm subsidies to a church with a farming operation. USDA probably believed a Hutterite colony is operating as a business but a Hutterite colony is really operating as a nonprofit religious organization. I believe the USDA determination of the Hutterite's eligibility for farm subsidies is a case of mistaken identity.

In order to correct the problem, I believe it may be necessary to revise the USDA farm subsidy program eligibility requirements. To accomplish this step, it may be necessary to revise the Farm Act in the Commodity Programs section of the Farm Bill. I believe the House Committee on Agriculture can make a determination about the steps that need to be made to resolve my complaint and, if necessary, make revisions to the Farm Bill. I believe the termination of the USDA farm subsidies given to all Hutterite colonies in the USA can be accomplished by setting up the farm subsidy program eligibility requirements to say:

- a) A nonprofit religious organization is not eligible for USDA farm subsidies.
I would include [a nonprofit organization is not eligible for USDA farm subsidies].
- b) A business must offer the standard full-time permanent public employment position to be eligible for USDA farm subsidies.
- c) A business must show their IRS tax filing information to be eligible for USDA farm subsidies.

I realize that a revision to the USDA farm subsidy program eligibility requirements and a revision to the Farm Bill can terminate the Hutterite's farm subsidies, but the termination may not apply retroactively to the Hutterite colonies that are currently receiving farm subsidies. I believe the termination of the Hutterite's farm subsidies should apply retroactively to all Hutterite colonies that are currently receiving farm subsidies. I will agree to provide you with the EWG farm subsidy database information, and relevant information, for any new Hutterite colonies I find, if requested.

I have enclosed a copy of 2 articles about a court case King colony was involved in concerning eligibility for Medicaid benefits. The court case is referred to as Hofer v. Montana Dep't of Public Health and Human Services, December 6, 2005. King colony claimed that their financial assets are shielded from their members being able to access the financial assets. DPHHS argued that King colony established a "trust relationship" through its founding documents, so colony members have access to the colony's financial assets. King colony's net worth is estimated to be about \$2.1 million. A trial judge ruled in favor of the Hutterites, but the Montana Supreme Court ruled in favor of the state Medicaid agency to deny Medicaid benefits to the Hutterites. I hope this information is helpful to you for resolving my complaint.

I have enclosed a list in progress of the Hutterite colonies in the USA that are receiving USDA farm subsidies as of 2006. I have enclosed a list of additional Hutterite colonies that are receiving USDA farm subsidies as of 2006. I am using 2006 as a time-frame year since the EWG farm subsidy database has USDA farm subsidy information for Hutterite colonies for the time-frame 1995-2006, expressed as a total financial amount. I have included contact information for the Hutterite colonies. The contact information comes from the [www.implu.com] and [www.manta.com] websites, and Internet phone

directories. I have enclosed a copy of webpages with Hutterite colony contact information from both websites to establish the credibility of my contact information.

The information used to establish the names of Hutterite colonies comes from a database at the following websites:

- a) [www.feehhs.org]
- b) [www.thecommonlife.com.au/pdfs/American_Communities.pdf]

I have enclosed a copy of webpages with the names of Hutterite colonies from the website [www.feehhs.org] as confirmation of known Hutterite colonies on my lists.

At this point, I am finished making my case for the termination of the Hutterite's USDA farm subsidies. I have enclosed documentation as evidence to support my case. The next part of the text includes my request for a statement from the committee, information about the progress of the resolution of my complaint at USDA in Washington, DC, allegations concerning Secretary of Agriculture Tom Vilsack allowing a violation of the public-interest to occur and his misconduct in office, and additional information.

I am requesting a statement from the House Committee on Agriculture concerning the resolution of my complaint. I will want to know the following points:

- a) Do you believe the Hutterite's USDA farm subsidies should be terminated.
- b) If you believe the Hutterite's USDA farm subsidies should be terminated then what steps will you make to achieve termination.
- c) If you believe it is necessary to revise the Farm Bill to accomplish the termination of the Hutterite's USDA farm subsidies, and to change the USDA farm subsidy program eligibility requirements to terminate the Hutterite's USDA farm subsidies, then I will want to know the specific revisions to the Farm Bill, the title of the Farm Bill that will include the revisions, and the information necessary to find the revisions in the Farm Bill so I can read the revisions.

I filed my complaint, as my original complaint, with the following individuals at USDA in Washington, DC, in 2008:

- a) Ed Schafer - Secretary of Agriculture
My complaint is available for Mr. Schafer to review.
- b) Chuck Conner - Deputy Secretary of Agriculture
My complaint is available for Mr. Conner to review.
- c) Glen Keppy - FSA/Associate Administrator for Programs
Mr. Keppy is acting as a coordinator for my complaint.
- d) John Johnson - FSA/Deputy Administrator for Farm Programs
Mr. Johnson is acting as an investigator for my complaint.
- e) Terry Jackson - OGC/Deputy Assistant General Counsel

Mr. Jackson is acting as a legal counsel for my complaint.

I received 2 letters from John Johnson as statements concerning the resolution of my complaint. I have enclosed a copy of Mr. Johnson's letters. Mr. Johnson believes in the following points:

- a) In reference to a 'closed admission policy', a 'open admission policy' is not a eligibility requirement for participation in USDA programs.
- b) A nonprofit religious organization can be eligible for USDA farm subsidies.
- c) There is no statutory or regulatory requirement for an entity to offer employment positions to the public.
- d) There is no support in statute or regulation to require a USDA farm subsidy recipient to establish a return of equal value to the public's investment.
- e) There is no statutory or regulatory basis for denying USDA farm subsidies to a Hutterite colony for the reasons I established as a basis for terminating their USDA farm subsidies.

In response to Mr. Johnson's letters, there may not be any law on the books to deny a Hutterite colony's eligibility for USDA farm subsidies but I believe a Hutterite colony's eligibility for USDA farm subsidies still has to pass the test of right or wrong. I believe USDA can make a determination to work to change a farm policy that is allowing a violation of the public-interest to occur.

I filed a updated version of my complaint, and Mr. Johnson's 2 letters, with Teresa Lasseter, USDA-FSA/Administrator, in 2008. I requested a reconsideration of Mr. Johnson's letters, and a statement concerning the resolution of my complaint, from Teresa Lasseter. At this point in time, I have not received a statement from Teresa Lasseter. I can confirm by my US Postal Service certified mail receipt that her office received my complaint and I have e-mail records of my correspondence with her concerning my complaint. I have enclosed a copy of the US Postal Service certified mail receipt, and the track and confirm information, for confirmation.

I sent a updated version of my complaint to the USDA Secretary of Agriculture office for Chuck Conner, Ed Schafer, and Tom Vilsack, the newly appointed 2009 Secretary of Agriculture, so they will have the same basic information as your committee. I have enclosed a copy of the US Postal Service return receipts I received from the USDA Secretary of Agriculture office for the complaints I sent to Chuck Conner, Ed Schafer, and Tom Vilsack, for confirmation that my complaint is available for them to review. I have enclosed a copy of the US Postal Service certified mail receipts, and the track and confirm information, for the complaints I sent to Chuck Conner, Ed Schafer, and Tom Vilsack, to confirm the date of delivery. All of the individuals I have filed my complaint with at USDA in Washington, DC, will now have the same basic information as your committee.

I received a e-mail, dated 3/4/09, from Candace Thompson, USDA-FSA/Acting Deputy Administrator for Farm Programs, on behalf of Secretary of Agriculture Tom Vilsack. The e-mail is a response to the e-mail I sent to the Secretary of Agriculture, dated 2/17/09, and to the updated version of my complaint I sent to Tom Vilsack. According to Candace Thompson, Tom Vilsack considers my case closed.

If this is Mr. Vilsack's position then he will allow the Hutterites to continue to receive USDA farm subsidies and will not act to change the USDA farm subsidy program

eligibility requirements, or farm policy in the Farm Bill, to accomplish the termination of the Hutterite's USDA farm subsidies.

In the e-mail I sent to the Secretary of Agriculture at [agsec@usda.gov], dated 2/17/09, I informed Mr. Vilsack that I had filed a updated version of my complaint, including the new evidence of the IRS tax filing information for Hutterite colonies, with Teresa Lasseter, USDA-FSA/Administrator, in 2008. I informed Mr. Vilsack that he could contact Teresa Lasseter for information concerning the resolution of my complaint.

In the complaint I sent to Tom Vilsack, I stated that I had filed a request for reconsideration of statements I received from John Johnson, USDA-FSA/Deputy Administrator for Farm Programs, concerning the resolution of my complaint, with Teresa Lasseter. I stated that I had requested a statement concerning the resolution of my complaint from Teresa Lasseter. I stated that I had not yet received a statement from Teresa Lasseter.

If Mr. Vilsack considers my case closed then he has failed to consider Teresa Lasseter's resolution of my complaint and is obstructing the administrative function of the USDA Farm Service Agency's Office of the Administrator. I believe Mr. Vilsack is violating the appeal process of filing a request with the FSA/Administrator for a reconsideration of a statement the public receives from a FSA staff person. I believe my case at USDA should remain open to allow Teresa Lasseter to perform her administrative function of resolving my request for reconsideration, resolving my complaint, and making a statement concerning the resolution of my complaint.

Based on evidence, I am making the following allegations concerning the Secretary of Agriculture Tom Vilsack:

- 1) Secretary of Agriculture Tom Vilsack is allowing a violation of the public-interest, as a financial loss for the USA public, to occur by closing my case at USDA and failing to act to terminate the Hutterite's USDA farm subsidies. The Hutterite's USDA farm subsidies result in a financial loss for the USA public.
- 2) Secretary of Agriculture Tom Vilsack is obstructing the administrative function of the USDA-FSA/Office of the Administrator by not allowing Teresa Lasseter, USDA-FSA/Administrator, to perform her administrative function of resolving my request for reconsideration, resolving my complaint, and making a statement concerning the resolution of my complaint.

As evidence to support my allegations, I have enclosed a copy of the following e-mails:

- a) A e-mail I received from Teresa Lasseter, dated 10/1/08. This e-mail will establish her awareness that I wanted to send my complaint to her.
- b) A e-mail I sent to the Secretary of Agriculture, dated 2/17/09.
- c) A e-mail I received from Candace Thompson, dated 3/4/09.

As evidence, I have enclosed a copy of the USDA Farm Service Agency Organizational Chart for 2008, from the website [www.fsa.usda.gov]. The chart establishes the position of FSA/Administrator (Office of the Administrator) as the head of the Farm Service Agency. The chart will make it clear that Mr. Vilsack has chosen to establish Candace Thompson as his spokesperson for resolving my complaint and has chosen to reject Teresa Lasseter as his spokesperson for resolving my complaint, as established by the e-mail I received from Candace Thompson, dated 3/4/09.

I am requesting that the House Committee on Agriculture investigate my allegations

concerning Secretary of Agriculture Tom Vilsack.

My complaint is a public service to the USA taxpayer, so I will be bringing my complaint to the attention of public-interest groups like the following groups:

- a) Citizens Against Government Waste (CAGW)
- b) Environmental Working Group (EWG)
- c) Public Citizen

I believe these groups will want to know the resolution of my complaint.

For more information about the Hutterites you can contact Vance Youmans. He is a history instructor at Spokane Falls Community College and he is the author of a book on the Hutterites entitled 'The Plough and the Pen'. Dear Mr. Eichhorn:

I appreciate your enthusiasm about joining a Hutterite colony. If you are this persistent and determined about joining a Hutterite colony, it seems that you are very capable of achieving many other things, like finding and holding a job. I am glad to see that you do not lack determination, which will serve you well in life.

However, I would like to reiterate what my son stated in his response to your introduction letter. I realize that he may have been a bit blunt, and apologize if he offended you in any way. He was trying to convey, in no uncertain term, that it is impossible for you to join a Hutterite colony. I have brought your letter to the attention of our colony members and other members among different colonies. We are all in agreement that it is impossible for you, or anyone else, to join a Hutterite colony. The fact that you are German has no bearing, what so ever, on joining a Hutterite colony. I have also read the letters you send to the Spring Creek Colony. In it you, in my opinion, forcefully state that since our information is in the public domain, we have an obligation to the public to honor anyone's request of a visit. I disagree. We reserve the right to decline a visit to anyone we feel is unwelcome. We have extended an invitation to you to come and visit for a day, during our first phone conversation. We made it clear that you may visit but not stay. We do not have a responsibility to allow everyone and anyone to visit.

Please realize that there is no future with the Hutterites. Your energy used to pursue this matter can be better spent elsewhere. Please do not send any more letters, money, or call any Hutterite colonies. We have given you our answer. Please accept it.

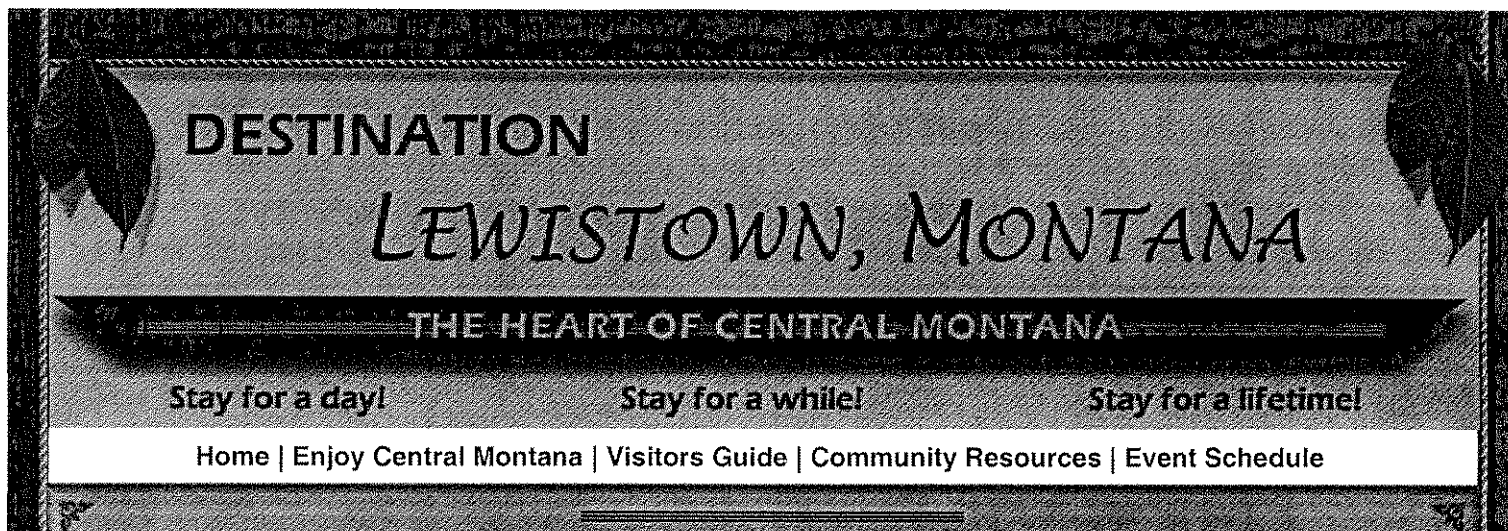

LEARN ABOUT THE HUTTERITE COLONIES OF CENTRAL MONTANA

History

The Hutterites are a religious group originating from the Reformation of the 16th century. In the early 1520's, the ferment identified with Martin Luther and the Reformation spread to a group in Switzerland that came to be known as the Anabaptists as they believed in the rebaptizing of adults. The Anabaptists additionally shared a belief in the separation of Church and State and they were committed pacifists. The branch of the Anabaptists that we know as Hutterites was founded in Moravia in 1528 by Jacob Hutter and is distinguished from other Anabaptist sects such as the Mennonites and the Amish by its belief in the community of goods in which all material things are held in common. The Hutterites survived periods of persecution and suffering alternating with periods of prosperity leading to their eventual migration to North America in 1874. Initial colonies were established in the Canadian Prairie provinces and the Dakotas and they prospered until great tension developed during World War I as a result of their pacifist beliefs. Those tensions gradually disappeared during the great depression and during World War II, the Hutterites again refused to participate, but engaged in other forms of alternative public service. Today there are about 45,000 Hutterites living on 460 colonies of which about 50 are in Montana. Additional information on the history and beliefs of the Hutterites are at www.hutterites.org.

Hutterite Life Today

Hutterites are a communal people living on scattered bruderhofs or colonies throughout the prairies of North America. Their religion is unique in that all material goods are held in common. All members of the colony are provided for equally and nothing is kept for personal gain. In every Hutterite colony, the minister or spiritual leader is also the chief executive and he, along with an advisory board, makes the day to day decisions. The advisory board consists of the minister, the colony manager, the farm/ranch manager and two or three witness brothers (deacons) who are elected for life.



Early education has always played an important role in Hutterite life and usually takes place in public schools located at the colony. More recently, many young colony children go on to public high schools and some are beginning to pursue college degrees. The Hutterites are by nature very hospitable and neighborly and frequent opportunities are found for visiting and joint projects with neighbors or other colonies. Wonderful insights into daily life on a Hutterite Colony are in the book by Lisa Stahl, *My Hutterite Life*. Another great source is Bill Allard's articles in the National Geographic. See <http://ngm.nationalgeographic.com/2006/06/hutterite-sojourn/allard-text>. A distinguishing characteristic of the Hutterites is their entrepreneurial spirit and initiative. A visit to a colony always has surprises in terms of produce or crafts or unique services that fill a niche in the local economy.

Ayers Colony

Hello! My name is Marilyn Stahl and I'm a resident of the Ayers Colony. We are located about 6 miles west of Grass Range, 23 miles east of Lewistown on Highway 87. The Hutterites at Ayers Colony came from Austria to Huron, South Dakota where they had resided since 1874. They purchased their land in Montana from former Montana governor Roy E. Ayers in 1944. The Colony currently has 9 families with a total population of 42 persons. Our Colony was the first to record Simmental cattle in the United States. We had cow number 22 in the American Simmental Association and sold bulls and club calves all over the US and Canada.



We have lots of special activities at the Colony that we are proud of. My mother, Anna Stahl, always has some prized poultry she enjoys raising and my brother Bill is Chief of the Cheadle Rural Fire Dept and is always happy to show off his latest fire fighting equipment. My Dad, John Stahl, loves to give tours of the Colony's modern meat processing facility that handled over 700 animals last year. In addition to my work at the Colony, I have been a first responder for the Grass Range Ambulance District for over 10 years and have recently been elected Chief Election Judge for the Grass Range Election District. Another specialty of our Colony is catering meals for special occasions with such delicacies as roast pig or roast quarter of beef.

We always welcome visitors to the colony with advance notice. Give me a call at 406-428-2207 and we can discuss your interests and the kind of visit that you'd find most rewarding.



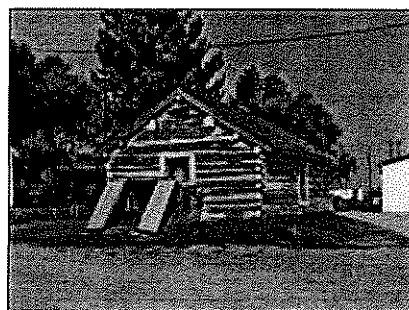
King Colony

Hello! My name is Rita Hofer and I am pleased to introduce to the King Colony. We are located about 10 miles west of Lewistown on Highway 87 and then 2 miles north along Kolin/Ross Fork Road. Our Colony now owns the King Ranch which was one of the most famous and prosperous ranches in this part of Central Montana. It was first settled by Christ King in 1881 and the original cabin he built still stands on the property. The Ranch was operated by two sons, Anton and Joseph, until a combination of difficult economic conditions during the Great Depression and Joseph's death in 1934 led to the sale of the Ranch to a Hutterite Colony led by Reverend Joseph Stahl in 1935. Our Colony now has 13 families and a total population of 55 people.



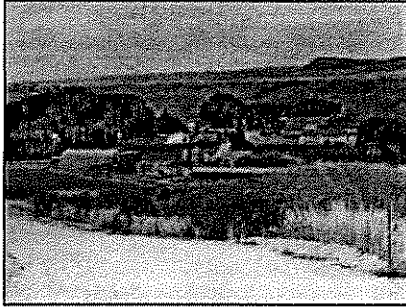
Many of our farm and ranch operations are for our own consumption, but we do have a commercial dairy and cow/calf operation. I keep very busy with work at the Colony but also find time to Chair the local School Board and work as a precinct election worker. I am especially proud of the pheasant wreathes and I also do sewing craft work. My husband "Shorty" (Walter) Hofer works with the farming. I have always been an advocate of higher education for the children and am especially happy that my son Wesley is pursuing his college degree on line.

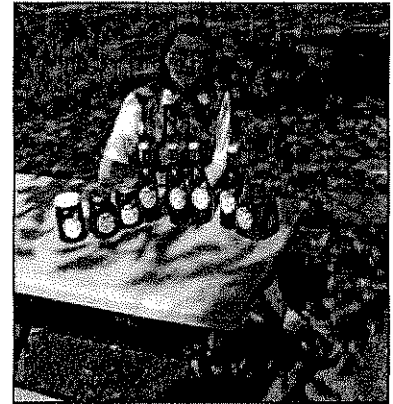
Spring Creek Colony

Hi! My name is Kathy Walter. I am a member of the Spring Creek Colony located 14 miles northwest of Lewistown on Highway 426. Our Colony has a long history that goes back to 1912 when the King Ranch sold the lower (north) portion of their Ranch to a Hutterite Colony led by Jacob Stahl of Wolf Creek, South Dakota. During World War I, however, persecution of the Hutterites due largely to their pacifist beliefs and German heritage led them to sell the Colony and emigrate to Canada. Subsequently, in 1946, Jacob Walter and Paul Walter led a colony that that once again purchased the ranch. Today, we have about 20,000 acres with 13 families and a total population of 46 people. Like the King Colony, we have a commercial dairy and a cow/calf operation in addition to much agriculture that we pursue for our own consumption.



We stay very busy at the Colony but find time to do volunteer work with the rural fire department in Moore. If you come visit, I'll be sure to show you our beautiful new kitchen and dining complex of which we are very proud. We also have special interests that we pursue when time permits. I am particularly known for my wild Chokecherry and wild Juneberry jellies and syrups. My husband Jim is quite a builder and recently has been making sheds and small storage buildings for people in the area.

Timeline Hutterites

THOUGHTS

955: Emperor Otto I defeated the Magyars, and Moravia became part of the Holy Roman Empire. It was part of the Kingdom of Bohemia. At times, Moravia had a ruler with sufficient fortitude that Moravia was enabled to maintain a semblance of separate rule. However, it ultimately was Bohemian. Also, to note, these lands were part of Austria.

1516: Dutch religious scholar, Erasmus of Rotterdam wrote a copy of the Greek New Testament and transcribed it into Latin as well. Erasmus implored scholars to translate the Bible into every language. This encouraged many groups to study the Bible, and form their own opinions. Out of this came the Anabaptist group in 1525 who carried out adult baptism.

1525: January 21: Zurich, Switzerland: Felix Manz, priest from the Tyrol, George Cajacob, Conrad Grebel, theology student, were amongst a group meeting at the home of Manz to study the Bible. They concluded that the Bible instructed them to renounce infant baptism, and that persons should be baptized as adults. Conrad Grebel first baptized George Cajacob, and then Cajacob baptized the rest. Sixteen **adults** baptized that day. And so, began the separation of Church and State, adult baptism, adoption of a disciplined way of life, separation from nonbelievers, community of goods and pacifism. These Anabaptists' "ideas" are the basis of the Hutterites' beliefs.

1525: May: first Anabaptist was executed - by burning - by Catholic authorities in Schwyz

1526: Jacob Hutter, became acquainted with Anabaptists in Tyrol.

1527: Hebraist Felix Manz first Anabaptist executed by Protestants, drowned in Zurich's Limmat River

1528: In this year the Anabaptists split into several religious groups, under separate leaders. Because of persecution in Switzerland they had to flee. One group, led by Jacob Hutter, hid in the forest. They were very low on supplies, and Jacob implored them to put all of their goods into a coat he laid down, so the group could jointly make the best use of all its remaining resources. From then on, they decided to live according to Book of Acts (2:42), and share all things in common. They called themselves Hutterites after Jacob Hutter. Basic to the Hutterite beliefs is the "community of goods", sharing all physical goods for the benefit of the group. Before his death, Hutter founded approximately eighty six colonies.

1529: Jacob he joined a Tyrol Anabaptist group, chose to be baptized, and was picked as a minister.

1530s: Hutterite colonies in Moravia sending missionaries to areas of Europe.

1535: Jacob Hutter married Katherine Purst.

1536: Jakob Hutter burned at the stake because of religious beliefs

1540: Peter Ridemann wrote his Account of Our Religion, Doctrine, and Faith (Rechenschaft), while he was in a Hessian prison. During this time, it was very dangerous to be a Hutterite. They sought safety wherever possible. Many lived in caves and the catacombs of Rome.

1542: Peter Reideman was an elder from 1542-1556

1565-95: In the mid 1550s Hutterite colonies flourished in Moravia and Hungary. They were well off, well educated and well thought of. Academics in their schools were admired by the general population, and at that time Hutterite Doctors were often sought out by the wealthy. At that time, there were about 30,000 members.

1595: The religious climate changed and severe persecution began, again. People died and property was confiscated. A few managed to escape and emigrate to the Ukraine.

1570s: Because of Hapsburg/Turkish war, the government was short on money. Government confiscated some of Hutterite lands. Again, in 1584 and 1589.

1612: Around 1612, in Moravia, the Hutterites became well known/respected for their ceramics and pottery. They crafted many types of utensils/plates/etcetra for the home. Because of their quality and esthetics, these dishes and ceramic items were widely sought by the wealthy and nobles of the area. It was common for a noble to purchase whole cartloads of dishes, ecetra from the Hutterites. Many of these items which were saved in museums and collections have been wrongly labelled as Habaner faience. In fact, such items are Hutterite work.

As well, such was the quality of their other work, large quantities of this was also purchased by the wealthy, either for their own use, or as gifts. There are records of Moravian barons gifting foreign noblemen with items such as: gilded horse carriage, iron bedsteads, knives and earthenware, as well as fine ceramics.

Middle classes purchased Hutterite items too. Not all were the price range of the wealthy.

Hutterites had unique techniques for clay mixtures, colors and design in manufacturing ceramics and pottery. It was a secret knowledge which they kept to themselves. It was different from similar products from other groups/countries, and much in demand. They used unique types of yellow and white clay, not all of it local. Also, their dyes, ornamentation, glazes and manufacturing process was unique.

1618-1648: Thirty year war. Many Hutterites were killed. Colonies were pretty much disbanded. Many Hutterites escaped to Slovakia and Transylvania. Few were left behind.

1621: During one of the wars between the Turks and the Holy Roman Empire, one of the leaders, Bethlen Gabor, Prince of Transylvania invited the Hutterites to move to Transylvania, and he would give them freedom from persecution and safety. They refused his offer. Prince Gabor did not leave the matter. In 1621 he sent wagons, and forcibly moved 200 Hutterites to his lands in Transylvania. During the remainder of the thirty years war, these Transylvanian Hutterites thrived and survived, free from harrassment. ((Not so their brethren who remained behind.))

1622: Hutterites, that were left, were expelled from Moravia. Many went to Hungary

and Russia.

1750: Oldest German settlement in Canada, started with 2400 Protestant German farmers and tradesmen from the Southwest of Germany landed with their families in Halifax

1767: In the years leading up to 1767, Slovakia and Transylvania had a new Empress, Maria Theresa. Maria Theresa was a devout Catholic and determined that all under her rule should also be Catholic. She supported and encouraged the Jesuits to wipe out all other faiths. This ended, again, in severe persecution for the Hutterites. All worship other than Catholic was outlawed. Some Hutterite children were permanently removed from their parents (what did the state do with them?), and even old people were removed and placed in institutions. Only about sixty Hutterites remained. In 1767 these escaped across the Transylvanian Alps to Wallachia, near Bucharest.

1768: War broke out between Turkey and Russia. Situated as they now were, the small group of Hutterites was caught in the middle, between the two armies.

1770: Russian commander-in-chief, Count Rumiantsev, offered the Hutterites safe haven and free land on properties he had acquired in the Ukraine, near the Desna River. Hutterites lived here in the "Russian" Ukraine for more than one hundred years. This was a time when they were allowed freedom from persecution. During this time some Hutterites left their colony and joined Mennonite settlements.

1809: It was about this time, there was a breakdown in "community goods". Perhaps due to extensive political upheaval and on/off persecution, it was possibly necessary for individual ownership, if any property/goods were to survive ownership.

1859: Leaders Jakob Hofer, Darius Walter, and Michael Waldner succeeded in re-establishing the "community of goods".

1870s: Russia enacted laws to force Hutterites to speak Russian, and serve in the military. Again, Hutterites decided to move and began emigrating to America.

Roughly, they emigrated in three waves, under three Men. Dariusleit (the Darius people---Darius Walter), the Lehrerleit (the teacher people---Jakob Wipf, a school teacher and elder) and the Schmiedeleit (the smith people---Michael Waldner, a blacksmith), with the names of the groups taken from the occupations of each leader. South Dakota was where colonies were first established.

1874: This is the year the majority of Hutterites left Russia for North America. They settled in North America in three major colonies. The names for the colonies were taken from the three leaders of the colonies. The beliefs and practices of all three was the same. Small changes might have included such matters as slightly different styles of dress, etcetra. 1) Schmiedeleut (blacksmith) was the first colony, so called because their leader was a blacksmith. Generally Manitoba, Canada and South Dakota, USA is where these people settled. 2) Dariusleut was the second group, so named for their leader, Darius Walther. 3) Lehrerleut was the third group. Again, it was named for its leader. Hutterites from Alberta, Saskatchewan, (Canada) and Montana (USA) generally are the last two groups.

1897: The colonies in the United States were flourishing. Hutterites owned five flour mills, as well as spinning, carpentry, shoemaking, blacksmithing, book binding, and broom-making workshops. As well they were farmers.

1899: Agreement between Hutterites and Canadian government, supports the Hutterites religious lifestyle, but there has still been controversy on and off over the years.

1918: President Woodrow Wilson would not guarantee the Hutterites freedom from military service, and many of the colonies emigrated to Canada, to safeguard their pacifism.

Even so, fifty six Hutterites were caught up in the draft and attempts were made to force them into service. Most suffered severe abuse/torture, in efforts to convince them. Two died in the process.

1918: Michael and Joseph Hofer were the two who died, under terrible conditions, upon adhering to their religious convictions.

In subsequent military service, Hutterites were allowed to discharge their obligation by non military work such as national parks. In all, about fifty Hutterite families came to Canada, first in Alberta and Manitoba, then in Saskatchewan.

1942: Canada passed the Veteran's Land Act. This act established the law that land had to be offered for sale for sixty days before Hutterites were allowed to purchase it.

1942: Alberta passed the Alberta Land Sales Prohibition Act. This made it illegal for anyone to sell land to a Hutterite or an enemy alien.

1944: The Land Sales Prohibition Act will be struck down as beyond the power of the province because it also mentions enemy aliens. The Alberta government will re-enact the law (S.A. 1944, c.15) removing references to enemy aliens.

1947: Canada passed the Land Act pertaining to Hutterites. It restricted Hutterite land purchases, as well as size and location of colonies. They had to be at least 40 miles apart, and no larger than 6,400 acres. Colonies used to be situated closer to each other, but with these regulations, there is now more distance between them. One of the side effects of this greater distance is forcing the Hutterites to do more travelling to visit other colonies. As well, they also end up having more interaction with non Hutterites, simply because that's who there neighbours are.

1947: Alberta Communal Property Act S.A. 1947, c.16 will allow Hutterite colonies to be established if they are set up at least 40 miles from existing colonies. It also limited the size of existing colonies.

1950: Hutterites joined the three separate groups together, under one name to give themselves a better position to safeguard their beliefs and prospects. Hutterische Bruderkerche (Hutterite United Brethren Church).

1960: Alberta Communal Property Act will be amended to permit increased land holdings by Hutterites with the approval of the Communal Property Control Board. The establishment of new colonies will require cabinet approval.

1972: Alberta repeals The Communal Property Act, which had been basically aimed at restricting Hutterites ownerships of farm lands.

1992: Schmiedeleut section of the Hutterites broke into two. They are now called Committee Hutterites or Group 2, and Schmiedeleut or Group 1. There were conflicts over policies, and also concerns that some of the group's rules were not adhered to. They split on opposite sides of this disagreement.

1995: A Hutterite teacher training program is set up at Brandon University---Brandon

University Hutterian Education Project (BUHEP). More than fifty Hutterites have graduated as teachers.

1996: Hutterites in North America totaled 37,297 (by census).

2001: Two Alberta teenagers have become the first members of their Hutterite colony to graduate with a high school diploma. Edna Walters and Joanne Stahl

2003: Some Hutterite colonies in Southern Manitoba build their own wireless Hutterian Broadband Network (HBN). They plan to use the sytem to access Distance Education oppotunities. They have done this in co -operation with Advance Pro, Sony of Canada Ltd. and Informatics Consultants

2005: There are approximately 458 colonies with 50,000 members in North America

2005: February 18: In a move which is unusual for Hutterites, they wrote to the Canadian Government to express their concerns should the Canadian Government change marriage laws to validate same sex marriages. They are unequivocally against such legislation.

2005 June 30: First Hutterite to run in a Marathon, the Manitoba Marathon. Lynda Waldner completed the 13.1 miles in two and three quarter hours. (Lynda Waldner wore complete traditional Hutterite dress.) As well, there were a further four Hutterites from Ms. Waldner's colony who competed in the marathon.

2005: October: Hutterite colonies go to cyber school. Seventy five Hutterite students are part of a cyber-school in Chester South Dakota.

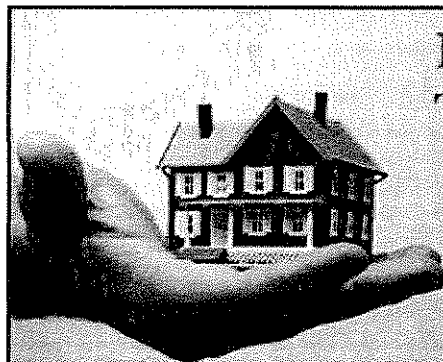

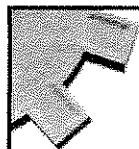

Non-profit organizations

non-profit organizations: an overview

A non-profit organization is a group organized for purposes other than generating profit and in which no part of the organization's income is distributed to its members, directors, or officers. Non-profit corporations are often termed "non-stock corporations." They can take the form of a corporation, an individual enterprise (for example, individual charitable contributions), unincorporated association, partnership, foundation (distinguished by its endowment by a founder, it takes the form of a trusteeship), or condominium (joint ownership of common areas by owners of adjacent individual units incorporated under state condominium acts). Non-profit organizations must be designated as nonprofit when created and may only pursue purposes permitted by statutes for non-profit organizations. Non-profit organizations include churches, public schools, public charities, public clinics and hospitals, political organizations, legal aid societies, volunteer services organizations, labor unions, professional associations, research institutes, museums, and some governmental agencies.

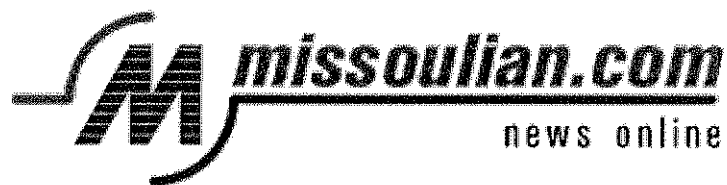
Non-profit entities are organized under state law. For Non-profit corporations, some states have adopted the Revised Model Non-Profit Corporation Act (1986). For Non-profit associations, a few states have adopted the Uniform Unincorporated Non-Profit Association Act (See Colorado §§ 7-30-101 to 7-30-119). Some states exempt non-profit organizations from state tax and state employment programs such as unemployment compensation contribution. Some states give non-profit organizations immunity from tort liability (see Massachusetts law giving immunity to a narrow group of non-profit organizations) and other states limit tort liability by enacting a damage cap. State law also governs solicitation privileges and accreditations requirements such as licenses and permits. Each state defines non-profit differently. Some states make distinctions between organizations not operated for profit without charitable goals (like a sports or professional association) and charitable associations in order to determine what legal privileges the respective organizations will be given.

For federal tax purposes, an organization is exempt from taxation if it is organized and operated exclusively for religious, charitable, scientific, public safety, literary, educational, prevention of cruelty to children or animals, and/or to develop national or international sports. Social security tax is also currently optional although 80 percent of the organizations elect to participate.

Hutterite colony in court over Medicaid coverage

HELENA, Mont. (AP) - The 53 members of the King Colony Hutterite community in central Montana live a communal, mostly self-sufficient life. Members of the religious group don't believe in individual property ownership and shy away from most government aid, including health care.

But now the colony is at the center of a dispute coming before the state Supreme Court this week over whether members are eligible for Medicaid benefits.

Seven women members of the colony, formally known as King Colony Ranch Inc., argue that they are being denied benefits because of their religious beliefs.

The state of Montana contends members don't qualify financially for Medicaid because they all have access to the colony's vast net worth, estimated at about \$2.1 million.

Russ Cater, chief legal counsel for the state Department of Public Health and Human Services, said the case could have far-reaching effects. If the state loses, he said, it could face a huge increase in the Medicaid benefits it has to provide to similar groups of people.

"Any communal living situation, I guess any family trust, family farm trust, it would be I think easy for a multimillion-dollar farm organization to put their income into some kind of a trust and indicate that they're going to send their members to welfare to apply for health benefits," Cater said.

In 1992, seven women from the Hutterite colony applied for and were granted benefits through Medicaid, the government program that helps pay for medical care for the poor.

Later, however, the state Department of Public Health and Human Services told them it didn't believe they qualified for the benefits and planned to cut them off at the end of 2001.

The department argued that King Colony established a "trust relationship" through its founding documents. The department contends that means those seven women have access to the colony's assets.

But attorneys for Rita, Anna, Bertha, Sarah, Marie and Judith Hofer and Mary Wollman, dispute that, arguing that the women have no vote in the colony and, therefore, no way to access those resources.

A state district judge ruled in favor of the women last March, but the state appealed. The hearing before the Supreme Court is scheduled for Wednesday.

Attorneys for the women declined to comment before the hearing, but argued during an earlier hearing that the state's interpretation that the women have access to the colony's assets is wrong.

"They don't own anything," Bozeman attorney Kent Kasting said of the women. "They can't _ they come into the world with nothing."

A woman who answered the phone at the colony declined to discuss the case, calling it a private matter. She declined to identify herself.

Court documents provide some picture of life on the ranch and outline the opposing sides in the dispute.

The Hutterites have roots in the 16th-century Anabaptist religious movement in Europe, the same movement that gave rise to the Mennonites and Amish. They live in communal agricultural colonies where the men and women have traditional roles and wear traditional clothing.

Technology is embraced on most colonies, as long as it helps advance the common good. Men use tractors and combines.

The women testified that they aren't always given money for groceries they'd like, to supplement the staple meat and vegetables they produce on the ranch. Most of their net worth is in farmland, crops and livestock.

According to court statements by John Stahl, an elder in the community, the men in the colony, who make all financial decisions, try to fully take care of the members but increasing health care costs prevent them from paying for medical care.

But Cater disagrees. He said the colony could sell some of its resources to cover medical expenses, just like other families who would otherwise qualify for Medicaid must often do.

"I think it was simply a business judgment that health care costs are rising considerably and if they can get someone else to pay for their health care costs in the end it would benefit their colony, their business, their members," Cater said.

And if they win in court, other Hutterite colonies may seek benefits too, he said.

"Right now not all colonies are sending their members to apply for Medicaid," Cater said. "It's only a few such as the King Colony, but we have received word from the other colonies that if the state loses this case they may have to reevaluate their past practices and perhaps send their members to ask for Medicaid assistance."

Members of Religious Colony May Not Qualify for Medicaid

Members of the Hutterian Brethren (usually referred to as Hutterites) participate in an unusual socio-religious exercise. Believers live in colonies, and every colony member transfers all his or her worldly goods to the religious order for control by the colony's directors, who hold all property for the communal good. So what happens when a Hutterite needs medical care?

Rita Hofer, Mary Wollman, Anna Hofer, Bertha Hofer, Sarah Hofer, Marie Hofer and Judith Hofer are all members of the King Colony Ranch, a Hutterite colony in Montana and one of 48 in the state (there are 77 others in North Dakota, South Dakota, Minnesota, Oregon and Washington, and another 344 in Canada). The seven women applied for Medicaid coverage for some of their medical care, and were found to be eligible for benefits in 1992. Then Montana authorities reconsidered, and the state's Medicaid agency ruled that the women should look to the colony's considerable wealth—estimated at more than \$2 million, though mostly in farmland—before expecting government assistance with medical care.

The Hutterite women appealed, arguing that they were being discriminated against because of their religious beliefs. They had no real ability to reach the colony's assets, they insisted, since all the business of the religious order is managed by a minister, and as women they do not even have the right to participate in his selection.

The Medicaid agency disagreed, and characterized the colony as akin to a trust. While each Hutterite transfers all his or her assets to the colony, reasoned the agency, the religious order in return agrees to support its individual members. That arrangement amounts to a trust, and each Hutterite would have the ability to force the colony to provide the promised support, by court action if necessary.

Although a trial judge found in favor of the Hutterites, the Montana Supreme Court agreed with the Medicaid agency's analysis. In its written opinion, the state's high court ruled that the Medicaid agency should determine the extent to which colony assets are "available" to its members, and what support each member has the legal right to expect from the religious order. *Hofer v. Montana Dep't of Public Health and Human Services*, December 6, 2005.

State Medicaid officials were unpersuaded by the Hutterites' claim that they can not pay the increasing costs of health care. Traditional families are forced to liquidate assets to pay for health care, Medicaid officials pointed out. If the King Colony Ranch could shield its assets members' health care costs, the agency feared that other groups could follow suit, create communal property ownership arrangements, and make every participant eligible for Medicaid.

Dear Mr. Eichorn:

This is in further response to your complaint about Hutterite colonies receiving payments under USDA programs. It is your contention that what you term "new evidence" should be a basis for denying payment to a Hutterite colony. You also object to this matter being considered closed.

Again, an "open admissions policy" is not an eligibility requirement for participation in USDA programs. A nonprofit religious organization can, in fact, be eligible for the payments you seek to deny. There is no applicable statutory or regulatory requirement for an entity to offer employment positions to the public. Likewise, your characterization of USDA payments to an eligible program participant as an "investment" requiring the public to receive a return of equal value has no support in statute or regulation.

We fully understand that you have your opinions and believe there is a "problem" that needs to be fixed. You are entitled to your opinions. However, there is neither a statutory nor a regulatory basis for denying the payments for the reasons you suggest. As indicated in our prior response, we consider this matter closed. We will provide no further response.

I believe a USDA determination of the Hutterite's eligibility for USDA farm subsidies is a case of mistaken identity. USDA probably believed Hutterite colonies are operating as a business but Hutterite colonies are really operating as a nonprofit religious organization with a tax-exempt status.

Secretary of Agriculture,

I need to inform you that I am sending a updated version of my Hutterite complaint to the USDA Secretary of Agriculture office for you to review. I believe you may want to make a decision concerning the resolution of my complaint. My complaint concerns the USDA farm subsidies given to over 100 Hutterite colonies in the USA. I am making the case to terminate their farm subsidies. I believe I can establish a legal foundation, based on evidence, to make the case.

The updated version of my complaint includes new IRS tax filing information for Hutterite colonies. The information shows that Hutterite colonies are filing with the IRS as a 501(d) religious and apostolic association and are tax-exempt.

I can establish a profile of a Hutterite colony as a nonprofit religious organization that cannot offer the same standard full-time permanent public employment position as a business can offer because of their tax-exempt status. Based on this fact, I believe a determination to terminate the Hutterite's farm subsidies can be made.

I filed my original Hutterite complaint with USDA in 2008. I filed a updated version of my complaint, including the new IRS tax filing information, with Teresa Lasseter, FSA/Administrator, in 2008. For information concerning the status of the resolution of my complaint at USDA/FSA you can contact her.

As a result of my complaint, I believe it may be necessary to revise the USDA farm subsidy program eligibility requirements and the USA Farm Bill to accomplish the termination of the Hutterite's farm subsidies. I will be filing my complaint with the House Committee on Agriculture, US Congress, Washington, DC, in 2009. I will notify the committee that my complaint is available for the USDA Secretary of Agriculture to review.

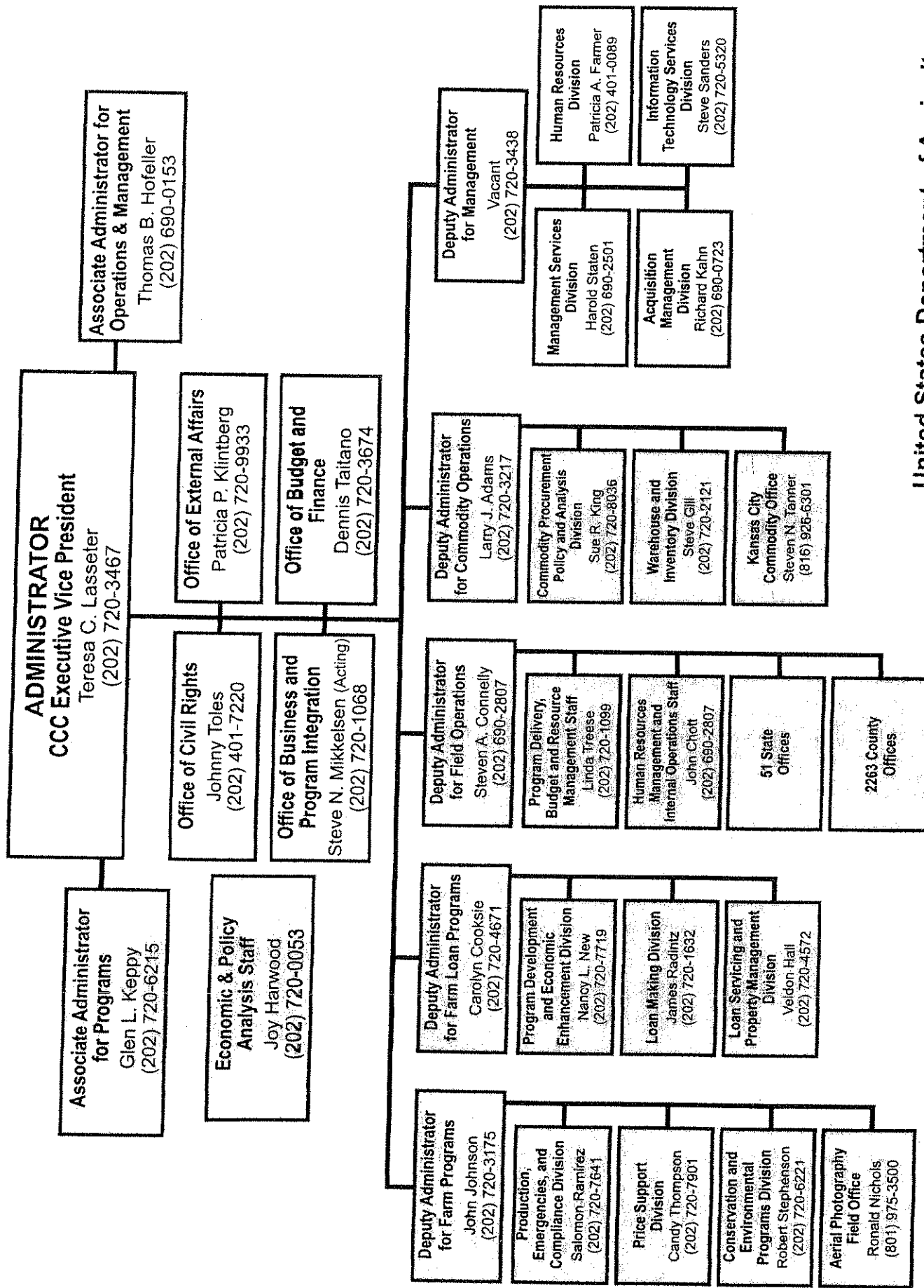

Background The "87 Dariusleut Colonies" list presented below represents the second of three sections of Appendix Fifteen *"Hutterite Society"* as of the last year reported by Hostetler in the first edition of his book. The last list -- the "65 Leherleut Colonies" -- will be posted soon.

At the time of Hostetler's first edition (1973-1974) he reported there were 229 Hutterite colonies in North America. He estimated they contained about 20,000 Hutterites. A 1996 estimate on the Internet states at least 400 colonies now exist with an average of 90 members per colony for a total of between 36,000 and 40,000 Hutteries.

An unknown number of other Hutterites in North America left communal life to become "Prairieleuts". They will not be found in the records of these groups of colonies, nor is a Juliusleut group in Ontario, Canada where relationships with about forty persons of the Enz family were severed in the early 1950's.

Also a related "Society of Brothers" (SOB), a "Buderhof" splinter group founded in Germany in 1920 by Eberhard Arnold (1883-1935) that spent some time in Paraguay is not included in this lists. In 1974 there were the SOB communities of Woodcrest in Rifton, NY, Oak Lane (became New Meadow Run) in Farmington Pennsylvania, Evergreen in Norfolk, Connecticut and Darvell at Robertsbridge, Sussex, England.

In 1973-74 the SOB under the leadership of the Rifton New York colony is said to have 1,000 persons. In 1996 they are thought to have about 300 persons per colony and perhaps as many as 8 communities. However at present time they are not part of the original Hutterite group founded in 1528 and thus not part of these lists either.

This information was transcribed by the webmaster into a Works database and reformatted into a "user friendly" flat file database for the web. In doing so the Colony "town" address was augmented with the county for U. S. Colonies. 
