The information provided on this site is the official, published version and the information retrieved from *GPO Access* can be used without restriction, unless specifically noted. This free service is funded by the Federal Depository Library Program and has grown out of Public Law 103-40, known as the Government Printing Office Electronic Information Enhancement Act of 1993.

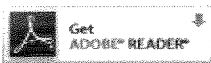

## About Open CRS

American taxpayers spend over \$100 million a year to fund the Congressional Research Service, a "think tank" that provides reports to members of Congress on a variety of topics relevant to current political events. Yet, these reports are not made available to the public in a way that they can be easily obtained. Open CRS provides citizens access to CRS Reports that are already in the public domain.

CRS Reports do not become public until a member of Congress releases the report. A number of libraries and non-profit organizations have sought to collect as many of the released reports as possible. Open CRS is a centralized utility that brings together these reports.

Unfortunately, there is no systematic way to obtain all CRS reports. Because of this, not all reports appear on the Open CRS web site. We believe that it would be far preferable for Congress to make available to the public all CRS Reports.

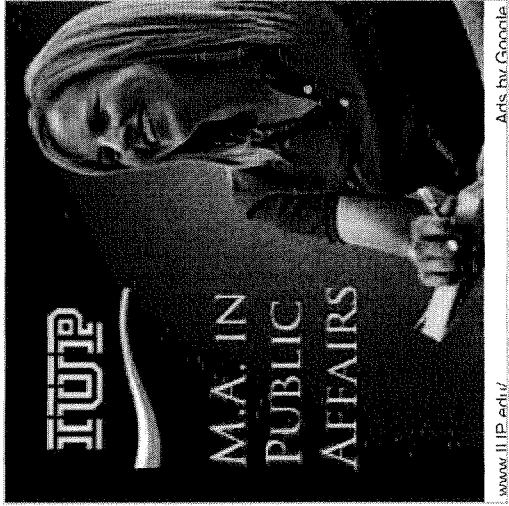

Teresa Lasseter grew up on a farm in Tifton, Georgia. She graduated from Abraham Baldwin Agriculture College with a degree in business administration. Lasseter worked for the Georgia Department of transportation directly after graduating college and before taking a part-time summer job in the FSA county office in 1977. She held a variety of positions while traveling the state and familiarizing herself with farm programs on the local level and entered the agency's management training program before stepping back in 1993 due to family concerns. A political appointment from then-Gov. Zell Miller kept her closer to home. She was executive director of the Georgia Agrirama Development Authority in Tifton, remaining there until 1999. During this time back at home she also chaired the Chamber of Commerce in Tifton. U.S. Rep. Saxby Chambliss led the effort to secure Lasseter's nomination by the Bush Administration to the position of FSA executive director for Georgia. One year later she was appointed the Associate Administrator for Programs (in the FSA) and asked to move to Washington, DC, where she worked from 2003 to 2004. Most recently, Lasseter served six years as the Executive Director of Tifton, Georgia's Agrirama Development Authority. The 30-year old Agrirama is an educational living history center dedicated to bringing rural life of turn-of-the-century Georgia to life. She was appointed chief of the FSA by agriculture secretary Mike Johanns in October 2005. She is the first administrator to have

worked her way up through the organization's ranks. She is also the first female administrator. Lasseter also serves as the executive vice president of the Commodity Credit Corporation, a wholly-owned government corporation with a \$30 billion line of credit with the United States Department of Treasury.

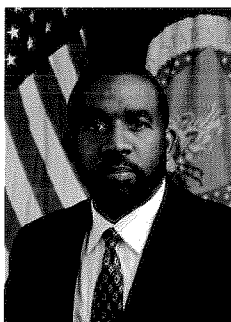

## Corporate Registry Searches

Corporate Registry is a centralized storehouse of information on all legal entities, businesses and non profit organizations registered within the province. This information is public information and is available to anyone upon request.

A request for information from Corporate Registry's records is called a 'search'.

There are four types of searches that are available:

- Current Search - current information on organizations such as how long the organization has been in operation, its' address, name of directors and/or shareholders, declarants, etc.
- Historical Search - the same type of information as given for a current search is available for all legal entities with the exception of trade names and partnerships (this information is for a specific past date)
- Certificates of Status - the current status of the organization, i.e., 'Active', 'Struck', etc. (a certificate of status is not available for trade names)
- Historical Certificates of Status - the status of the organization on a specific past date

Search results are provided in different formats, depending on when the information was collected and what technology was available at that time. For example, a corporation that was formed during the '70's would have their historical records on microfilm whereas a corporation that was recently incorporated will have their records stored in an electronic format.
